FINANCIAL POLICY:

I highly recommend you come in for 3 sessions within 3-6 weeks if you are new to Splankna or have pressing circumstances. Meeting frequently will be most beneficial as we work together toward your goals. You may experience shifts after the first session, or it may take a few sessions. Regardless of how often we meet, you agree to take full responsibility for your self-care in the emotional, mental, physical, and spiritual dimensions of your life between visits. From time to time, you may have a simple question or two after a session. Please feel free to text, email, or call me, and allow me 24 hours to answer.

I also arrange Intensive Sessions that range from 3 hours to working together over multiple consecutive days with breaks. Please inquire if you, your spouse, family, or someone you know is in crisis and needs intensive work. Longer sessions also make sense for clients who can't meet weekly but need several sessions.

In addition to the session rate, I charge \$30 for house calls. If we meet somewhere other than my office, this fee will be added. For example, if I travel to your house to see three family members for a total of 3 hours, \$480 will be due (\$450 + \$30).

Payments may be paid by Venmo, exact cash, check, credit card, or cryptocurrency.

CANCELLATION AND MISSED APPOINTMENT POLICY:

I consider any appointment that you have made with me important. Your appointment is for your exclusive use, and when it is canceled with short notice or missed altogether, it is often too late or impossible to offer this time to someone else, and the appointment time goes unfilled. If you need to reschedule, please let me know as soon as possible. Any cancellation that occurs within 24 hours of your appointment time is considered a late cancel. I understand that life is unpredictable, and unforeseen circumstances occasionally arise.

Please read and initial on all the lines below:

_____ The first late cancellation will have no fee.

_____ Any further late cancellations, and I will pay 100% of the session fee.

_____ If late canceling occurs too often, we may need to reevaluate.

_____ If I do not show for a scheduled appointment without a cancellation call or text, I will be billed for the full fee for the missed session/lose a session from my package.

_____ I agree to the posted rate, and I understand the late cancellation policy. If I need to cancel, I will email, call or text Kirsten within 24 hours or more. In the event that a Late Cancellation or No Show charge is due, I hereby authorize Kirsten to retain the full amount already paid, or agree to make a payment via Venmo within 24 hours of the missed appointment.
